Important

Before signing this form, seek legal advice from an independent and experienced Queensland lawyer.

Important information you must know:

- you will not own the land your home will be positioned on
- your site rent may be increased outside the terms of your site agreement in particular circumstances
- your site agreement may be terminated in particular circumstances.

This form must be used when a home owner (seller) wants to assign (transfer) their interest in a site agreement to a person who wants to buy their manufactured home (buyer). The seller, buyer and the park owner must complete and sign two copies of this form.

The seller must give two copies of this form signed by the buyer and seller to the park owner with a written request for the park owner's consent to the assignment.

The park owner must not consent to the assignment of the seller's interest to the buyer unless the park owner has given the buyer the precontractual disclosure documents, as set out in Schedule 1 of the Act, for the site:

- at least 21 days before giving consent; or
- at least 7 days before giving consent if the buyer has received legal advice and signed a
 precontractual disclosure waiver.

The park owner must not unreasonably refuse to consent to the assignment.

If the park owner consents to the assignment, the park owner must sign and return one copy of this form to the seller and keep the other copy until 1 year after the site agreement is terminated. **The seller must**, as soon as practical after receiving a signed copy from the park owner, give it and their copy of the site agreement to the buyer.

In signing this form, all parties acknowledge that the assignment is dependent on the consent of the park owner.

If the park owner refuses to consent to the assignment, the park owner must return both copies of this form to the seller and give the seller written notice of the decision and the reasons for the decision. This notice must also state that, if the seller is dissatisfied with the refusal, the seller must use the dispute resolution procedures in the Act to try to resolve the dispute and, subject to those procedures, apply to the Queensland Civil and Administrative Tribunal for an order that the park owner consent to the assignment.

If the park owner fails to make a decision about the assignment within 28 days after receiving the seller's request, the park owner is taken to have refused to consent to the assignment.
